

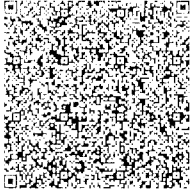

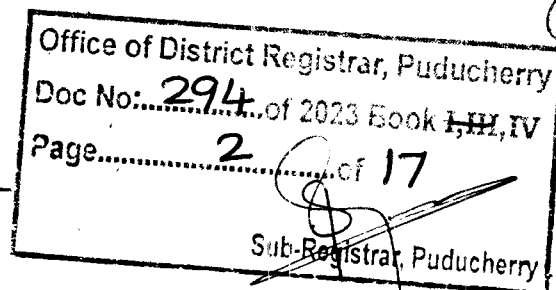

POWERS OF THE BOARD OF TRUSTEES:

The Trustees shall hold the Trust Fund upon the following terms:

1. The Board is entitled to establish and manage all kinds of schools, colleges, polytechnics, Universities and other institutions for boys and girls at various centers.
2. The Board of Trustees shall also be entitled to institute and grant scholarships, studentships for boys and girls studying in schools and colleges and other institutions and to supply for books, uniforms and other requirements connected with the promotion of their education
3. The Board of Trustees shall be entitled to organize the collections and raising of necessary funds for the purpose of achieving the above objects of Trust and for augmenting the Trust Funds and the doing of all such things as are incidental to the above objects of the Trust.
4. The Board of Trustees shall have power to take over the management of schools, colleges, polytechnics, hostels and other institutions from other authorities, Government, Municipal councils and other organizations or individuals or under direction from courts and maintain the same for effectuating the purpose of the Trust.
5. The Board of Trustees shall have power to deposit, invest, withdraw, purchase, sell, mortgage, redeem, take any property on lease, convert, consolidate, sub-

divide, renew or otherwise deal with securities or other assets movable or immovable held and owned by the Trust.

6. The Board of Trustees shall have power to receive gifts, to purchase, assign, sell, surrender, and lease and exchange movable or immovable properties owned by the Trust.
7. The Board of Trustees shall have power to appoint auditors for auditing annually the accounts of the trust and recording a report thereon together with a balance sheet.
8. The Board of Trustees shall manage the Trust Fund and collect and recover the interest, dividends and other income thereof.
9. The Board of Trustees shall pay and discharges out of the income of the Trust Fund all expenses and charges for collecting and recovering the income of the Trust Fund and incur all other costs, charges and expenses and outgoings of and incidental to the Trust created by these presents and the administration thereof.
10. The Board of Trustees shall have power to open current, savings, fixed deposit and other similar accounts with any scheduled Bank or Co-operative Bank if necessary.
11. To look into the day to day administrations of all educational institutions governed by the "SRI ANDAAL ALAGAR EDUCATIONAL TRUST".
12. Conducting examination, coaching classes, entrance test and other examinations to uplift the students and for these purpose they have powers to collect the fees.
13. To appoint or remove the Principal, Teachers, Clerical Staff and other officials to look into the day to day affairs of the school

14. The Board of Trustees have the power to alter or modify any one of the powers conferred on it for the welfare of the institution.

15. To admit students in hostels and to maintain the entire hostel administration.

The Trustees shall have all the powers necessary or incidental for effectually carrying, out of the objects of the Trust.

Subjects to the general provisions of the Trust and without prejudice to the general and specified power conferred upon the Trustees by the other provisions contained in these presents the Trustees shall have the following powers also.

1. Apply the trust money to effectuate one object or some of the objects of the trust as preference to the other objects.
2. Decide the nature, objects and functions of the institutions to be established by the Trust and to decide whether and if so that existing institution or institutions may be taken over by the Trust or to which financial aid may be given.
3. To enter into any contract on behalf of the Trust.
4. To acquire, build upon, pull down, re-build, add to, alter, repair, improve, sell or dispose of any lands, building or premises for the use of the Trust and to acquire other movable or immovable properties.
5. To expand the fund of the Trust in such manner as they shall consider of beneficial for the purpose of the Trust.
6. To determine if necessary, the terms and conditions on which any donations, subscriptions, scholarships or prizes or medals are to be given by the Trust.

7. In case it is decided to render financial or any other aid to any person or institution or to decide the terms and conditions that shall be complied with by such institutions.
8. To borrow any money upon the security of any of the properties of the Trust and to grant mortgage for securing the same or without any security and upon such terms and condition that the trustees may deem fit, borrow any money from banks or financial institutions.
9. In case of any of the trustee acts in such a way that may be detrimental to the trust or in case the majority of the trustees feel that such trustee is to be terminated from the trusteeship. Then three fourth of the trustees shall pass a resolution to that effect there upon he or she is terminated from the trusteeship and the Board of Trustees has the power to add a new Trustee if necessary.
10. To make and from time to time to repeal, add or alter regulation.
11. As to the management of the Trust and affair thereof.
12. As to the duties and remuneration of the Trustees, officers, or servants of the Trust.
13. As to the conduct of any of the matters or things, provided the same shall not be inconsistent with the provisions contained in the presents
14. To settle out of court, compromise or compound all suits, actions and other proceedings and all differences and demands, to arbitration's and to execute release and to settle and approve all accounts without being answerable for any loss occasioned thereby.
15. To appoint and dismiss manager, secretaries, clerks and other staff and works acquired for the working and for general management of the affairs of the Trust




#### MEETINGS AND NOTICES:

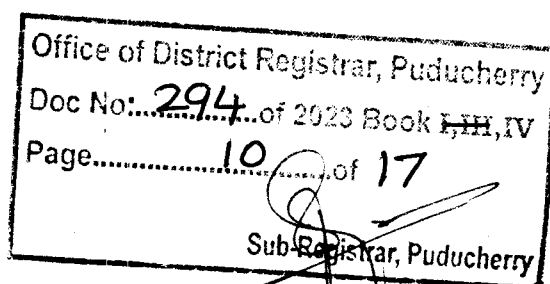
The Board of trustees shall meet at least once in a month to review the activities. In addition to the Annual meeting, the board may meet from time to time depending on the circumstances.

QUORUM:

The quorum for the meeting of Board of Trustees shall be three.

INVESTMENT:

The Trustees shall invest the surplus funds remaining after application of the income for charitable purpose by way of accumulation for any specific purpose of the Trust in such investments as are authorized under the Income-Tax Act, 1961.

ACCOUNTS:

Trustees shall maintain proper books of accounts which shall be closed on the 31<sup>st</sup> March of every year and get them audited by a Chartered Accountant.

BANKERS:

(a). The Bankers of the Trust shall be the Banks that may be decided by the Board of Trustees from time to time.

(b) All accounts with the Bank or Banks shall be opened in the name of the Trust and jointly operated by the Chairman and Treasurer/ Secretary.

The Trust shall have common seal.

BYE-LAWS:

The Board of Trustees shall have power to frame bye-laws not inconsistent with the Rules and Regulations of its functions and its proceedings and for a speedy and effective administration of the objects of the Trust.

1. The Trust is irrevocable
2. No part of the income or funds of the Trust shall be utilized for making any payment to any Trustee in any manner. They shall be utilized solely for the objects of the Trust.
3. No amendment shall be carried out to the Trust Deed except with prior permission of the Commissioner of Income Tax.
4. The activities of the trust shall be confined within the territories of India.
5. The Trust shall not carry on any activity with a profit motive.

If the Trust hereby constituted fails for any reason in the opinion of the Trustees the net assets of the Trust shall be made over to any other public charitable trust as decided by the majority of the Trustees.

AMENDMENTS:

1. While this trust shall be irrevocable, the board may amend the clauses relating to membership and management and also pertaining to the objectives of the Trust, which shall include deletion, amendment, addition of objective of the trust, at the duly convened meeting of the Board by a resolution passed by the three fourth of the Trustees, and for passing such resolution at least two weeks' notice shall be given to the persons entitled to attend such meeting.
2. If any alteration or amendment to the trust deed becomes necessary the same shall be carried out only with the prior approval as may be prescribed in the Income-tax Act, 1961 as amended from time to time.
3. If any alteration or amendment were necessary the same shall effected through supplementary deed / deeds and it / these shall be read together with this main deed

DISOLUTION OF THE TRUST:

If the Trust is to be dissolved, the funds, assets of the trust at the time of dissolution of the trust is to be transferred to a trust having similar objectives and under no circumstances it shall be distributed in any form to the authors, founders, trustees or members of the trust.

GENERAL:

1. The operation of the trust shall be carried out within India however this shall not prevent the trust form receiving funds either in cash or kind from foreign sources, within the provisions of Foreign Contribution (Regulation) Act.
